The CCEF program requires the customer/project owner to get CCEF's written approval for the rebate before the system is installed. Customer/project owner will be notified by e-mail within thirty (30) business days if their application has been approved, denied, or if more information is required. The approval notice will include the rebate amount and a Rebate Reservation Number from CCEF. (Contractor will receive a copy of the notice.) Only projects that will be installed by an approved contractor are eligible for a rebate.
